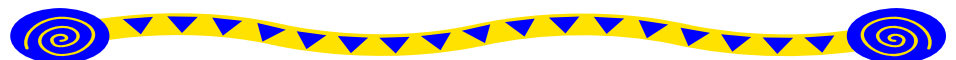
Merry Christmas

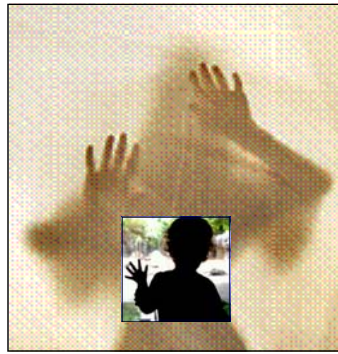

Ann Taught Workshop on *The Impact of Abuse* At CHOICES Retreat in January



Ann will be sharing her testimony in a number of places over the next few months. She will teach workshops for two more women’s retreats being sponsored by Victorious Walk Ministries, here in the Hill Country in April and October. She has been invited to speak for the Celebrate Recovery group in Boerne, TX, in April and will present a full-day workshop for LifePointe Church in Hutto, TX, the end of March. Romans 12:15 says, *“For you did not receive a spirit that makes you a slave again to fear, but you received the Spirit of sonship, and by him we cry, ‘Abba, Father.’”* Ann’s testimony opens the door for others to begin examining their own wounds and the lies they believe which hold them in bondage to a “spirit of slavery.” The child who was trapped physically by abuse grows up to be an adult who is trapped emotionally and spiritually. However, there is freedom if one is willing to receive God’s truth. This is the power of Ann’s testimony.

Mount Horeb House Going Non-Profit

After almost two years of prayer, deep personal healing and intense prayer ministry with others, we feel it is time for Mount Horeb House to apply for non-profit status. We are now in our eighth year as a ministry and feel the Lord is affirming a step forward with the ministry team that is forming around us.

Some of the advantages of having non-profit status are:

- Exemption from federal and/or state corporate income taxes (We have been hit hard with taxes over the past few years because we were not operating as a non-profit.)
- Possible exemption from state sales and property taxes (We are hoping to locate a ministry house in the near future, allowing us to take advantage of the ministry team to increase the number of people receiving prayer ministry.)
- Ability to apply for grants available only to 501c3 organizations (We do not qualify for those grants at this time.)
- Provision of additional liability coverage through incorporation.
